MULTITRADER LETTER OF DIRECTION & TRANSMISSION FEE ACKNOWLEDGMENT

Auto service (the "Service") will be charged a Software Transmission Fee (the "Fee") equal 30 % of all gain made on account using high watermark practice.

I request strategy "AI Fund" as my strategy provider.

I hereby instruct Axiory Global Ltd. to debit the Fee from my Trading Account, which will be wholly payable to MultiTrader Inc.

This authority shall continue to have effect until you have been given 7 business days Written Notice to the contrary. Any such amendment or termination shall not affect (a) any Instruction or Orders received from MultiTrader Inc.; and (b) any obligation of Axiory Global Ltd. to pay any sums due to MultiTrader Inc. in respect of any Transactions initiated, in either case prior to such Written Notice taking effect.

The Operative Agreements shall continue to have effect and in the event of any dispute concerning the implementation of this Authority the terms of the Operative Agreement shall prevail and have effect.

I acknowledge the following:
